New Officers for 2016

Saline County History & Heritage Society receives increase from the Saline County Quorum Court for 2016.

In a vote of the Saline County justices of the peace on December 16, 2015 the Saline County Quorum court approved an increase from \$1500 a year to \$4500 a year in support of the Saline County History & Heritage Society.

The process began back in October of 2015 when Steve Perdue, President of Saline County History & Heritage Society, made a presentation to the budget committee about the society's increasing utility and publication costs.


A delegation of supporters and members of the Saline County History & Heritage Society attended the budget committee.

Perdue was quoted as saying, "This increase will help tremendously with our operation expenses".

Perdue also expressed appreciation to the members of the Quorum court for their vote of confidence in the future of the Saline County History & Heritage Society, Inc.

Quorum court members watched a power point presentation which showed what the Saline County History and Heritage Society does. Photographs of county records and 2015 programs were presented in the presentation.

Saline Crossing Group receives \$500,000 dollar grant for preservation of the old Saline River Bridge

The Saline Crossing Group under the direction of former Benton Mayor Lynn Moore announced that the preservation group had received a \$500,000 dollar grant to

preserve the old Saline County bridge at the end of River Street in Benton. The group has worked tirelessly for this for many years. The bridge is important because it was the route of the old Military Road and Southwest trail. The bridge was built in 1891.

January 21, 2016 program to feature the B-17 Memorial on Hwy. 35 in Grant County.


Shirley Coppock, 1st vice president of the SCHHS, announced that the first program of 2016 will be about the B-17 Memorial in the Corinth community of Grant county.

A dedication was held of the park back in October of 2015.

A video will be shown of the park and the history of the B-17 that crashed during WWII and the man who organized the event and helped build the memorial will also be present to talk about the memorial.

If you have not been there it is worth the trip down Hwy. 35 toward Sheridan and turn left at the sign of Corinth Missionary Baptist Church.

The program will begin at 7:00 pm at the society's meeting room at 123 North Market Street in down town Benton.



New Dues Schedule for Membership Begins in 2016

The SCHHS board voted at the December meeting to change the dues for certain membership categories for 2016. There will no longer be an individual or couple membership but just household and that will increase from 20 to 25.00 a year. The organization (business and societies) went from 25.00 to 50.00 a year.

The remaining categories Contributing—\$50.00; Student (under 21)-\$15.00; Sustaining \$100.00; and Lifetime \$300.00 a year remained the same.

The new dues schedule became effective January 1st, 2016.

The board hopes that this will help us on the increasing costs of our publications and utilities.

SCHHS member has important role in B-17 memorial dedication



Geraldine Jackson , SCHHS member, received special recognition at the B-17 memorial dedication in October near Sheridan.

Geraldine's son, Jerry Jackson, was working on an Eagle scout requirement when he discovered the marker about the downed B-17 and was inspired to ask his father, Glendol Jackson, about the marker. He was later killed in an accident.

There is a marker in the park to Jerry Jackson.

Nine, aviators lost their lives in the crash of the B-17 on a training mission and their lives and memory have been honored at the memorial.

Other Grant County war veterans have also been honored at the park.

Governor Asa Hutchinson gave the dedicatory speech.
